THE PENINSULA YACHT CLUB YACHT MEMBERSHIP AGREEMENT

APPLICATION FOR YACHT MEMBERSHIP PRIVILEGES. The undersigned desires to obtain a Yacht Membership at The Peninsula Yacht Club and agrees to pay a non-refundable membership fee equal to \$______(the Membership Fee") and hereby submits this Yacht Membership Agreement to The Peninsula Yacht Club for further consideration. The required Membership Fee is based on the length, width and location of the particular marina slip requested as further described on Exhibit A which is attached hereto and if approved, the undersigned shall have access to marina slip number _____. The undersigned hereby agrees to pay the required non-refundable Membership Fee, plus all applicable taxes, in full upon submitting this Yacht Membership Agreement to the Club.

MEMBERSHIP PRIVILEGES AT THE PENINSULA YACHT CLUB; NO OWNERSHIP INTEREST IN THE CLUB OR THE CLUB FACILITIES. The undersigned acknowledges that the facilities provided at The Peninsula Yacht Club are currently owned and/or leased and operated by PYC Holdings, LLC, a North Carolina limited liability company, doing business as The Peninsula Yacht Club (the "Club"). The undersigned further acknowledges that membership privileges at The Peninsula Yacht Club is non-equity, non-proprietary and nonparticipatory. Membership does not imply any right or privilege to participate in or to administer business policies of the operation or maintenance of the facilities provided at The Peninsula Yacht Club and is not an investment in the Club or the facilities provided at The Peninsula Yacht Club and does not create any equity, ownership or proprietary interest or any prescriptive easement or other property interest of any nature in the Club, the facilities provided at The Peninsula Yacht Club or any other asset of the Club. Membership at The Peninsula Yacht Club allows the undersigned to use certain facilities provided at The Peninsula Yacht Club, but does not grant to the undersigned a vested or prescriptive right or easement to use such facilities. The undersigned does not have any interest in the income of the Club, and does not have the right to receive any of the Club's assets if the Club is dissolved. If approved, the undersigned only obtains a non-exclusive revocable license to use the facilities based on his/her Yacht Membership in accordance with the terms of the Membership Plan (as defined herein), as it may be amended from time to time.

PAYMENT OF CLUB MEMBERSHIP ACCOUNT. All dues, slip fees, fees, dining minimums, food, beverage, merchandise, services and other charges of the Club charged to the member's Club account will be billed monthly and shall be due upon receipt and shall be deemed delinquent if not paid by the last day of the month in which the statement was sent. The undersigned hereby agrees to pay all dues, fees and other charges incurred by the undersigned, immediate family members and their guests and to pay the Club account when due. Past due bills will accrue a late fee each month in an amount equal to a minimum late fee established by the Club from time to time and/or interest at a rate established by the Club not to exceed the maximum, non-usurious rate permitted by law from the date of the statement until paid in full. The undersigned further agrees to pay all reasonable attorneys' fees, investigation fees and other costs incurred in connection with the collection of delinquent accounts.

RESPONSIBILITY FOR YACHT MEMBERSHIP AT THE PENINSULA YACHT CLUB. The undersigned hereby acknowledges and agrees that he/she is responsible for his/her conduct and the conduct of his/her immediate family members and guests when using the facilities and shall be directly and fully responsible to the Club for any and all property damage and/or personal injury that are caused by, and for all charges incurred by, the undersigned and his/her immediate family members and guests. The undersigned understands that the Club shall not be responsible or liable for any property damage and/or personal injury occurring at the facilities, including but not limited to, any property damage or personal injury resulting from the actions of others.

THE UNDERSIGNED ACKNOWLEDGES THAT USE OF THE CLUB FACILITIES AND THE PARTICIPATION IN ANY EVENT OR OTHER ACTIVITY HELD BY THE PENINSULA YACHT CLUB EITHER ON OR OFF THE CLUB FACILITIES IS UNDERTAKEN WITH KNOWLEDGE OF RISK OF POSSIBLE INJURY AND THAT USE OF THE CLUB SIGNATURE REQUIRED ON SECOND PAGE > FACILITIES INVOLVES CERTAIN RISKS, INCLUDING, BUT NOT LIMITED TO, ALL RISKS ASSOCIATED WITH BEING IN AND OTHERWISE IN CLOSE PROXIMITY TO WATER AND WATERCRAFT. TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, THE UNDERSIGNED HEREBY ASSUMES ALL SUCH RISKS FOR THE UNDERSIGNED AND HIS/HER IMMEDIATE FAMILY MEMBERS AND GUESTS AND HEREBY FURTHER WAIVE AND RELEASE FOR THE UNDERSIGNED AND HIS/HER IMMEDIATE FAMILY MEMBERS AND GUESTS. ANY CLAIMS OR CAUSES OF ACTION WHICH HE, SHE OR THEY MAY HAVE AGAINST PYC HOLDINGS, LLC, PYC, LLC AND THE PENINSULA YACHT CLUB AND THEIR SUCCESSORS AND ASSIGNS OR THE DIRECTORS, SHAREHOLDERS, PARTNERS, MANAGERS, MEMBERS, **OFFICERS**, EMPLOYEES, AFFILIATES, REPRESENTATIVES, AGENTS, HEIRS AND THE FAMILY MEMBERS OF EACH OF THEM, ARISING OUT OF PERSONAL INJURIES OR PROPERTY DAMAGE WHICH HE, SHE OR THEY MAY SUSTAIN AS A RESULT OF USING THE CLUB FACILITIES OR PARTICIPATING IN ANY EVENT OR ACTIVITY HELD BY THE PENINSULA YACHT CLUB EITHER ON OR OFF THE CLUB FACILITIES, SUCH WAIVER SPECIFICALLY INCLUDES, WITHOUT LIMITATION, ANY CLAIM OR CAUSE OF ACTION ARISING OUT OF, OR IN CONNECTION WITH, ANY ACT OR OMISSION, WHETHER DUE TO NEGLIGENCE OR OTHERWISE, OF PYC HOLDINGS, LLC, PYC, LLC AND THE PENINSULA YACHT CLUB AND THEIR SUCCESSORS AND ASSIGNS OR THE DIRECTORS, OFFICERS, SHAREHOLDERS, PARTNERS, MANAGERS, MEMBERS, EMPLOYEES, AFFILIATES, REPRESENTATIVES, AGENTS, HEIRS AND THE FAMILY MEMBERS OF EACH OF THEM.

RECEIPT OF MEMBERSHIP PLAN. The undersigned hereby acknowledges receipt of the Plan for the Offering of Memberships at The Peninsula Yacht Club and the Rules and Regulations dated February 2005 (collectively, the "Membership Plan") which is incorporated herein by reference and hereby further agrees to abide by all of its respective terms and conditions as amended from time to time. The undersigned acknowledges and agrees that he/she has had the opportunity to review the Membership Plan and to seek professional advice to assist in evaluating the merits and risks of obtaining a Yacht Membership and that the undersigned has determined to acquire a Yacht Membership without reliance upon any information or representations other than as set forth in the Membership Plan and this Yacht Membership Agreement.

The undersigned acknowledges and represents to the Club: (i) that he/she is acquiring a Yacht Membership at The Peninsula Yacht Club for the personal use, enjoyment and recreation by the undersigned and his/her immediate family members, (ii) that he/she is not acquiring a Yacht Membership at The Peninsula Yacht Club for investment purposes, and (iii) that he/she is not acquiring a Yacht Membership at The Peninsula Yacht Club with the expectation of any pecuniary gain, economic profit or other financial benefit.

MEMBERSHIP FEE IS NOT REFUNDABLE. The undersigned hereby acknowledges and agrees that the Membership Fee paid to the Club for a Yacht Membership shall not be refundable under any circumstances, including but not limited to, the resignation of membership privileges, the suspension and/or termination of membership privileges or under any other circumstances.

This Yacht Membership Agreement and the Application for Membership Privileges shall be governed by and construed in accordance with the laws of the State of North Carolina without regard to principles of conflicts of laws. If the undersigned applicant is married, then the signature of the spouse is required.

THE PENINSULA YACHT CLUB Proof of Insurance

Such certification shall be filed on or before the Commencement Date. Thereafter, *Member* shall be required to maintain in the office of *Dock Master*, a current up-to-date copy of the certification of insurance demonstrating compliance with the terms hereof. Said policies shall not be canceled for any reason unless and until *Dock Master* is given thirty (30) days' notice in writing by the insurance company. All such certificates shall be filed with *Dock Master*, on or before the expiration date of the previously filed certificate of insurance. Failure to provide such information upon five (5) days written notice shall be a default hereunder and *Dock Master* may remove the Boat at *Member's* expense from the facility.

I have insurance from my own insurance agent or company. If I fail to show proof of my own insurance coverage I agree upon signing this document to assume all responsibility for the hull coverage as well as indemnity and liability coverage of my vessel.
